- a. Expanding Cooperative Purchasing Agreements. Administration recommends joining the Hunterdon County Educational Services Commission (HCESC) and New Jersey Cooperative Purchasing Alliance (NJCPA) to extend our ability to purchase through cooperatives.
 - Resolution 2023-12: Resolution Authorizing the Mahwah Public Library to Enter into a Cooperative Pricing Agreement [with the Hunterdon County Educational Services Commission].
