- b. Electronic Fund Transfers for the Payment of Bills. At the Board's request, administration explored options for electronic fund transfer (EFT) to pay vendors as an alternative to paying via check. Should the Board wish to proceed, next steps include developing policies and procedures for EFT for approval in November, and testing in December, with adoption in January 2024.
- c. Amendment to the Code of Conduct. Administration recommends raising the age at which children may be left unattended in the Library from seven to nine years old.
- d. Draft policy concerning children in the Library. Administration recommends adopting a policy addressing parents' rights to monitor their children's use of the Library; the age at which children may be left unattended in the Library, and in Library programs; staff's intervention when a child exhibits disruptive behavior; and actions taken when a child is left unattended after closing.
- e. Draft policy concerning 3D printing. Administration recommends adopting a policy to govern the use of 3D printing, including cost and outlining items that are prohibited from being printed in the Library.
- f. Purchase of canopy tops for the children's fiction collection. Youth Services identified a lack of space for new children's fiction as a major concern during a review of youth collections over the summer. Administration requested quotes for canopy tops to be added to the children's fiction shelving that allow for much-needed display space and recommends the purchase thereof.
